







Financial Report







COUNSELLING

At Saffron Centre, our dedicated team strives to provide the best quality of care to as many people as possible who need our services. Over this last year, our counselling department has focused on identifying and minimizing several potential barriers to accessing our services. These efforts have resulted in changes to how we intake new clients, creative responses to increasing wait times, policy changes to increase access to our services, increased or new programming to meet identified client needs, and staff education.

Our efforts to remove barriers started in the summer of 2022 by making updates to our intake process. Our focus was to ensure that we gathered only the most relevant information needed to support our clients in selecting the best program and therapist fit for their current needs. We also found and removed some administrative barriers, which has helped us to be able to schedule some clients more quickly into their first sessions. 467 individuals reached out to us for support during the year.

This year has also seen increased collaboration with community partners and improvements in how we receive referrals from these other programs (i.e. Victim Services Units, Zebra Centre), which has resulted in increases to our overall intake numbers. We saw a 19% increase in the number of individuals reaching out to our counselling department. Although increased intakes are welcomed as a sign that individuals are better able to connect with us for services, it does often result in increased wait times. In January and May, we hired additional staff and contract therapists to add to our effort to keep wait times low. Overall, we were able to maintain an average wait time of 8 weeks for the entire fiscal year (only 4% higher than the previous year).





COUNSELLING



Another way Saffron has worked on identifying and removing barriers for clients is by ensuring our policies are in line with research-based best practices. One example is that we had several staff, representing various Saffron departments, participate in an exploration of the ethics, Standards of Practice, and research as it applies to policies about reporting assault histories to the authorities. As a result, in January 2023, the counselling department implemented a change so that minors are only required to report to authorities when it is mandated by law. Since

then, we have noticed several new intakes for minors where this change removed barriers for our services. In addition, further research projects were made possible this year due to a new collaboration with the MacEwan University undergraduate psychology program. We hosted four field placement students over the year, and they have helped us with research on best practices around particular topics related to client barriers. As a result of some of this work, at the end of the fiscal year we put in place policy changes that will allow past clients options to re-access therapeutic supports in the event of a new assault, court appearance, or reactivation of trauma symptoms. We also continue to follow up on research on staff wellness and staff retention.

Saffron continued to reduce client barriers by growing and adapting our programs over the course of the year. Demand for the Foundations of Healing program, both individual and group, was up this year. Additional staff were trained in order to increase our capacity to provide individual and group facilitation of this program. Specialized Police and Court Support Counselling, a trial program from the previous year, was continued this year and adopted into our standard services. Saffron also expanded our services through a new partnership with the City of St. Albert. We have teamed up to offer in-person sessions for St. Albert residents at the St. Albert FCSS offices, for children, youth, and adults. Our Healing and Beyond group offered their first in person session during this year. It was very well received by the group members and now this monthly group is hosted 8 times a year online, and 4 times a year in person. We also added a second offering of the Healing and Beyond Group due to growing demand. In addition, time has been spent this year researching and developing new group content which will be offered early in the next fiscal year (Sept 2023).

COUNSELLING

Finally, with the growth to our counselling team this year, we were able to expand our availability back into Saturdays on a weekly basis. Overall, we increased the number of clients served by 10% for the year, and the number of children and youth clients increased by 38%.

Finally, diversity within the counselling team increases our ability to meet our clients' unique needs. Saffron's robust work culture includes an assortment of therapist designations and counselling approaches. In addition to our intern therapists, trauma coaches and clinical facilitators, we also have licensed social workers, psychologists and Canadian certified counsellors working and consulting together, sharing strengths, philosophies and camaraderie. Our staffs' assorted trainings have all been aimed, in a variety of ways, at best supporting our clients, who have been impacted by sexual violence. In addition to courses for working with survivors of sexual trauma, numerous hours of more specialized study and training was spent learning more about chronic suicidality, working with Complex PTSD, Acceptance and Commitment Therapy (ACT), ethical note writing, Emotionally Focused Therapy Externship (EFT), Deep Brain Reorienting (DBR), dissociation, personality disorders, Integrating EMDR with Play Therapy, Sandtray Therapy, "4 Blinks" training, EMDR and Pain, Advanced EMDR 2.0, and Trauma Specialization in Clinical Counselling Hypnotherapy. Not all staff participated in all the trainings, but each freely shares their knowledge and understanding in case conferences and consultations as we work together to formulate the best ways to address individual client needs.

Overall, our team was able to provide 432 clients a total of 3517 hours of counselling services. We saw an increasing number of clients choosing to resume in person sessions (44%), up from 18% last year. A significant number of individuals continue to find it a better fit for them to attend either by video (50%) or by phone (6%). We are happy to be able to offer a variety of options so that our clients can find what works best for them.

JUSTICE

Saffron's Specialized Police and Court Support (SPCS) Program serves the community as a victim services program specific to sexualized violence. Our trauma-informed team is comprised of highly trained advocates who are passionate about supporting individuals and families navigating complex investigative and judicial systems. SPCS Advocates provide information, advocacy, and emotional support at every stage of the criminal justice process. This year, we were proud to support **126 clients** through the police and court program, an **increase of 6%** from last year.

SPCS services are free and available to clients of any age who would like support with reporting, investigations, documentation, and court processes. We recognize that the criminal justice system is complex and can cause re-traumatization. Our team equips clients with as much information as they need to feel prepared for the next step of their journey, without judgment. We do this through reporting preparation and accompaniment, court preparation sessions, assistance communicating with Crown Prosecutors, accompaniment to court, documentation support, and completing check-ins and follow-ups with families.

SPECIALIZED POLICE AND COURT SUPPORT COUNSELLING PROGRAM



Last year, in collaboration with our Counselling Department, our team launched a new program for clients with major court dates approaching. To support clients specifically to prepare for court, Saffron launched our SPCS Counselling Program, providing up to 5 free sessions of solutions-focused therapy for clients. In the 2022-23 year, we provided **27 court counselling sessions to 14 clients** with trial approaching. The focus of sessions is to work with clients to identify their strengths and fears around attending court and find coping strategies that best suit their needs. Information is shared with Specialized Police and Court Support Advocates, who accompany the client to court and facilitate the strategies throughout the day as needed.



PARTNERSHIPS

Our SPCS Program is grounded in critical partnerships with criminal justice agencies and community organizations. We have a significant partnership with the Strathcona County RCMP through our joint Supported Reporting Protocol designed to assist individuals impacted by sexual violence with trauma-informed reporting to the Police. Saffron also works collaboratively with the Strathcona County Victim Services Unit and other VSUs surrounding the Edmonton area, the Edmonton Rural & Regional Response Office, The Edmonton Crown Prosecutors Office, and the Sherwood Park Courthouse. Community partnerships are also critical to providing comprehensive support to clients and their families, and include A Safe Place, the Zebra Child & Youth Advocacy Centre, the Family Resource Network, and the Alberta Association of Sexual Assault Services Network. Our Justice, Research, and Outreach team would not be able to do what we do without the support of our community partnerships.

FACILITY SUPPORT DOG YUKON

In April 2022, our team welcomed Facility Support Dog Yukon from the Lions Foundation of Canada Dog Guides. Facility Support Dogs are service-trained and accredited through Assistance Dogs International with their handlers. Yukon spent the last year supporting Saffron clients in



over 280 sessions, including counselling, court, police interviews, staff support, and crisis work. She has also attended dozens of community engagement events. In April of 2023, our local RCMP detachment lost a member on duty. Yukon spent multiple days in the Strathcona County detachment with sworn and civilian employees, providing emotional support and comfort to the team. She continues to regularly visit the detachment to say hello to our officers and raise awareness about the work Saffron is doing. She also assists clients looking to report sexual violence to the Police.

RESEARCH

Saffron's Justice, Research, and Outreach team work on projects each year to keep our practice current and relevant for clients. Research is primarily done by students, who contribute hundreds of hours each quarter assisting our staff with program development. Last year, research projects included staff well-being, court counselling practices, client counselling resources, and new educational material.

Saffron also received funding last year from the Government of Alberta to create a new educational program focused on the prevention of technology-facilitated sexual violence among youth. The issue of online sexual exploitation and sextortion has increased significantly over the last few years, and evidence has emerged on best practices for the intervention and prevention of online sexual violence. The new program created by Saffron includes three new presentations, all launching in September 2023.

OUTREACH

Saffron's staff and volunteers contribute hundreds of hours towards community outreach and engagement, including events hosted by Saffron, community festivals, convention booths, and meetings with community partners to reduce barriers to accessing Saffron services.

SCHOOL PARTNERSHIPS



Last year, Saffron partnered with three schools in our service area to raise awareness about our services and promote a culture of consent in the school, working with the administration to reassure students that they are not alone and have support. We attended monthly throughout the school year during lunch hour, bringing games and our Facility Support Dog, Yukon. The turnout was outstanding! Students became familiar with Saffron and its mission and were often seen wearing #GotConsent buttons in the hallways or playing with Saffron stress balls. Saffron would like to extend our sincerest gratitude to M.E Lazerte High School, J. Percy Page High School, and F.R Haythorne Junior High School for their collaboration and partnership.



COMMUNITY COLLABORATION

Saffron is a member of several networks and working groups in the communities we serve. Notable collaborations include the Violence, Trauma, and Suicide Prevention Protocol in Strathcona County, Strathcona County and Fort Saskatchewan Interagency, the Strathcona County Community Safety and Well-being Committee, Northern Alberta Human Trafficking Collaboration Meetings, and the Centre to End All Sexual Exploitation Working Group.



Other impactful community partnerships include our specialized work with RCMP and Crown Prosecutors' Offices surrounding investigative and court processes for our shared clients. Saffron and Strathcona County RCMP's joint Supported Reporting Protocol allows individuals who have experienced sexual violence to choose how and where they would like to report to the police. RCMP also assisted Saffron in setting up a satellite interview and monitoring room which was used in several sexual assault interviews last year. Saffron continues to be a warm referral partner to Strathcona County and Fort Saskatchewan Victim Services, the Bridge Youth Hub, the Canteen Youth Hub, and the Family Resource Network, and last year became a regular referral partner with the Zebra Child and Youth Advocacy Centre.





PUBLIC EDUCATION

Saffron has a highly reputable Public Education program, including proactive and preventative education on relationships, boundaries, consent, sexual violence, and online safety for all ages. Our team delivers presentations for Kindergarten through Grade 12 and offers caregiver and professional training to parents, teachers, businesses, and community agencies. Our team delivered 648 presentations and trainings this year, up 13% from the previous year.

COMMUNITY EDUCATION

Our year in community education was busy and diverse. Our team delivered sexual assault and harassment education to all Sherwood Park Kings Hockey Club players in October 2022 as part of their Character Symposium and trained coaches and managers on receiving and handling disclosures of sexual violence. We also trained the coaches and managers of the Sherwood Park Minor Hockey Association in collaboration with the Family Resource Network in Strathcona County. Last year, Saffron trained hundreds of teachers at several Sherwood Park, Fort Saskatchewan, St. Albert, and Edmonton schools and community groups on managing disclosures of sexual abuse and exploitation from youth. This included a training at the North Central Teachers Convention in Edmonton in February 2023. We also trained over 300 adult professionals through the Department of Justice last October, focusing on the topic of online child sexual exploitation.





NEW CURRICULUM

Toward the end of our fiscal year, our Public Education team set out to create a new educational program for children and youth. We expanded service delivery options from 4 to 7 presentations in the Junior High and High School range and changed the formatting of our Elementary presentations to be interactive for children. We also aligned all our presentations with the Health and Life Skills Curriculum Outcomes from Alberta Education to assist teachers with the completion of their curriculum goals. The new curriculum finished development at the end of the fiscal year with a launch date of September 1, 2023.

VOLUNTEERS AND EVENTS

VOLUNTEERS

Volunteers continue to contribute meaningfully to the work at Saffron Centre. From our volunteer board, to intern therapists, and event volunteers, these dedicated people make a significant impact on our organization and clients. In 2022-23, 76 volunteers contributed an incredible 3811 hours of volunteer time!

CONSENT EVENT

In May, we hostedour 8th annual "Consent Event," a fun run/walk fundraiser. This event happens during Sexual Violence Awareness Month and represents a significant event for raising awareness about the devastating impact of sexual violence and how we can all be involved in creating a safe community free from sexual violence. With 137 participants, this was a biggest Consent Event so far with welcome community support, from individuals and groups, community groups, and corporate sponsors.

This year's Consent Event helped raised \$23,241 from both Corporate Sponsorships and Participants. The funding contributes to our counselling, public education and Justice departments thriving, as well as raising public awareness within the community about who we are and what services we provide. None of this would have been possible without the 50 volunteers we had helping to ensure the day's events ran smoothly, many of whom volunteer with us year after year.
